

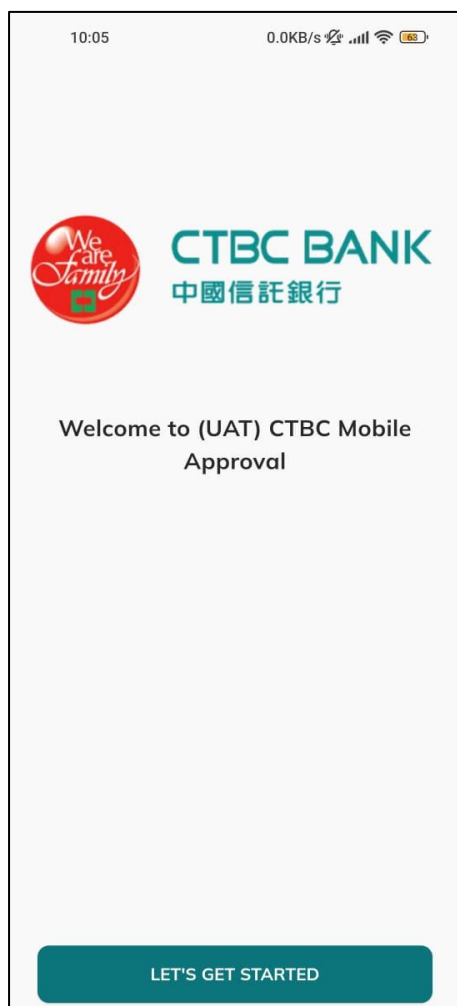
1. Activation

After downloading and installing the Primecash Corporate Mobile app, Company Officers must first activate the app with an OTP before using it. This menu function is used to authenticate Company Officers who wish to log in to the Primecash Corporate Mobile app for the first time. If the Company ID, User ID, and Login Password entered by the user are correct, the system will send an OTP according to the configuration (in the System Configuration for Companies module in the Bank Officer module) via SMS, Company Officer Email, or a combination of both. The Officer can then enter the OTP on the screen. If the OTP entered is correct, the system will validate the Role and User Group to retrieve the list of Menus and Pending Tasks accessible to the Officer on the Home page.

1.1 Activation CTBC Mobile Approval

The steps to activate the **CTBC Mobile Approval app** are as follows:

1. Open the **CTBC Mobile Approval app**. The **Welcome page** will be displayed.

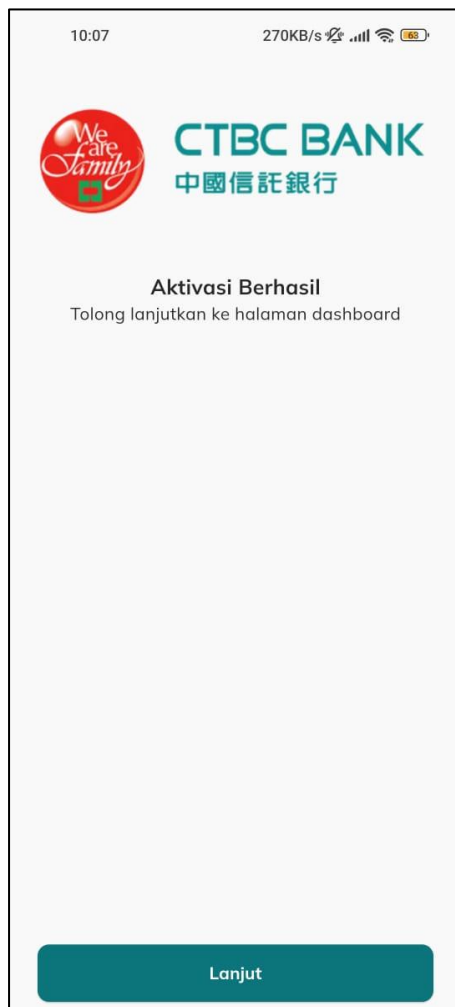
